FIBER OPTIC BY AT&T COMING SOON

AT&T will be analyzing the grounds in Landis Lakes this fall to plan their strategy to install underground fiber optic lines later next year. The actual installation will take place the end of Qtr. 1 or beginning of Qtr. 2 of 2022.
